



**Young Adult Volunteer Parental/Legal Guardian Consent Form
(For minor under the age of 18)**

I hereby give consent for my child/ward _____ to serve as a volunteer for The Grateful Garment Project (TGGP). I understand that my son/daughter/ward will be provided with any orientation and training necessary for the safe and responsible performance of his/her duties, and will be expected to meet all the requirements of the volunteer position, including adherence to TGGP's policies and procedures. I also understand that my child/ward will not receive monetary compensation for the services contributed. I will support my son/daughter/ward by respecting their volunteer commitment and will provide transportation, if needed.

WAIVER AND LIABILITY RELEASE

I assume the responsibility of the mental and physical fitness of my child/ward to participate in the assignment and agree to abide by all rules and requirements of the program. I also understand that failure to abide by the above may lead to my termination from the volunteer program.

I understand that my child/ward is not considered an employee of TGGP for the purposes of Workers' Compensation, but that TGGP may or may not provide volunteer accident insurance in excess of any other medical insurance I may have. I agree to comply with the TGGP's policy on reporting any injuries my child/ward incurs while under TGGP's supervision.

I agree to hold harmless TGGP, its officers, staff, employees and volunteers from and against any and all liability arising out of or in any way connected with my child/ward while volunteering with TGGP.

I understand my child/ward is responsible for corresponding with the volunteer coordinator in a timely manner regarding any scheduling changes, sick/vacation leaves, or questions.

I realize TGGP cannot be responsible for my child/ward after he/she leaves his/her assignment or for any personal belongings.

I give perpetual permission to TGGP to use, transmit, replay, or broadcast for internal or external purposes, without charge and without reservation, the following information in publishing and promoting the activities or the services of TGGP: photographs and/or video of my child/ward, my child's/ward's likeness, my child's voice; and my child's/ward's personal demographic information (such as first name, age, and hometown).

I waive any rights of action I and/or my child/ward may have and release TGGP from any claims I and/or my child/ward may have arising from such use, including any rights to sue for defamation or violation of rights of privacy or rights of publicity.

This waiver and liability release shall apply to myself, as well as any of my heirs, executors or administrators.

THIS RELEASE SHALL APPLY EVEN THOUGH LIABILITY MAY ARISE OUT OF NEGLIGENCE OR CARELESSNESS ON THE PART OF THOSE DISCHARGED INCLUDING THEIR EMPLOYEES, AGENTS AND VOLUNTEERS. I HAVE FULLY INFORMED MYSELF OF THE CONTENTS OF THIS RELEASE BY READING IT BEFORE I SIGNED IT. I REALIZE THAT BY SIGNING THIS DOCUMENT I AM GIVING UP LEGAL RIGHTS TO WHICH I MAY BE ENTITLED.
